**ESTABLISHMENT ORDER NO. 22 / 2019**

In pursuance of approval of the Directorate General of Human Resources Development Indirect Taxes & Customs, New Delhi conveyed vide letter F. No. 901/06/Admn/HRD/2015/2835 to 36 dated 25.04.2019 of the Additional Director (Admn), DGHRD, Indirect Taxes & Customs, New Delhi, Shri Ankit Shokeen, Inspector, GST & Central Excise, Alwar is transferred to the Directorate General of Human Resources Development (I&W/EMC), Indirect Taxes & Customs, New Delhi on "Loan Basis" for a period of 2 years, on the following terms and conditions:

- (i) No transfer T.A. and joining time will be admissible to him in this event of transfer on "Loan Basis", since this transfer is being allowed on his own request;
- (ii) On this transfer on "Loan Basis", he will not be entitled for promotion, confirmation, seniority, etc. in the Direct General of Human Resources Development, Indirect Taxes & Customs, New Delhi;
- (iii) While Working in Directorate General of Human Resources Development (I&W/EMC), Indirect Taxes & Customs, New Delhi on "Loan Basis", he will remain on the working strength of GST & Central Excise, Jaipur Zone. All kinds of payments to him towards his pay and allowances will have to be borne by his parent Commissionerate i.e. GST & Central Excise Commissionerate, Alwar. He will not be entitled to any kind of special pay, allowance, etc; &
- (iv) He is liable to be returned back at any time to his parent Zone without assigning any reason.

2. On having accepted the above terms and conditions, Shri Ankit Shokeen, Inspector may be relieved immediately to report to the Directorate General of Human Resources Development (I&W/EMC), Indirect Taxes & Customs, New Delhi under intimation to this office.

3. This issues with the approval of Chief Commissioner, GST & Central Excise Zone. Jaipur.
