In this regard, it is stated that the information sought in respect of acceptance of CESTAT, Delhi find order No. 34-35/2005-NB(A) pronounce on 30.12.2004 in the case of M/s Shree Krishna Industries. In this case the appeal was filed against the Order in Original No. 12/2004 dated 20.08.2004 passed by the Commissioner of Central Excise, Jaipur-II. Since the Order-in-Original was passed by the Commissioner of Central Excise Jaipur-II and the matter pertains to erstwhile Central Excise Jaipur-II Commissionerate as the unit was falling under their jurisdiction at the respective time. Since the said file pertains to jurisdiction of Central Excise and Service Tax Commissionerate, Jaipur therefore, the relevant file has not been transferred to CGST Udaipur Commissionerate. However, as per the available record with this office copy of the register is enclosed but despite valiant efforts the file has not been traced out at this office.
