Consequent upon issuance of Trade Notice No. 03/2017 dated 22.06.2017 by the Chief Commissioner, Central Goods and Service Tax and Central Excise (Jaipur Zone), Jaipur in pursuance upon issue of Notification No. 01/2017- Central Tax to Notification No. 06/2017- Central Tax, all dated 19.06.2017 and Notification No. 01/2017 - Integrated Tax & Notification No. 02/2017- Integrated Tax both dated 19th June 2017 issued by the Ministry of Finance, Department of Revenue, Central Board of Excise and Customs, New Delhi specifying the jurisdiction of the Chief Commissioner of Central Tax, Jaipur Zone and jurisdiction of the Commissioner of Central Tax, Udaipur, the jurisdiction of the Central Tax Division and Central Tax Ranges under each such Division of this Commissionerate is reorganized, as shown in table annexed as Annexure A to this Trade Notice No. 06/2017 dated 22.06.2017.

The Divisions / Ranges shall have jurisdiction over taxable persons under Central Goods and Service Tax falling within their respective jurisdiction.
